To protect the city in the pursuit of first and third-party claims based on the following losses: General Liability, Property, Auto Liability and Physical Damage, Workers' Compensation, Boiler and Machinery, Errors and Omissions, Law Enforcement, Inland Marine, Crime, Employers Liability, and Sexual Misconduct.
