WHEREAS, Resolution No. 24R-07-128 approved Change Orders #7, #8 and #9, however, the figures quoted were not accurate as it did not include all labor and fees thereby necessitating an amendment to update the total change order figures;

- NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:
- <u>SECTION 1</u>. That Resolution No. 24R-07-128 is hereby rescinded and replaced with this Resolution.
- <u>SECTION 2</u>. That Amended Change Order #7 which changed the previous agreement for scope of services with Ahren's Company, a copy of which is attached hereto and incorporated herein, is hereby approved for the amended amount not to exceed \$20,105.29 to install conduits for a new FP&L transformer.
- SECTION 3. That Amended Change Order #8 which changed the previous agreement for scope of services with Ahren's Company, a copy of which is attached hereto and incorporated herein, is hereby approved for the amended amount not to exceed \$4,602.96 to fix under ground pipes and lines for parking lights.
- <u>SECTION 4</u>. That Change Order #9 which changed the previous agreement for scope of services with Ahren's Company in the amount not to exceed \$21,168.00 to re-design the building department office area, a copy of which is attached hereto and incorporated herein, remains unchanged and is hereby approved.
- <u>SECTION 5</u>. Providing that payment shall be made from the appropriate Budget Code Number(s) in the total amended amount not to exceed \$45,876.25 for the above-referenced various change orders.
