A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA AUTHORIZING AN AGREEMENT WITH MATHENY MOTOR COMPANY FOR THE PURCHASE OF TWO (2) FIRE RESCUE VEHICLES, BOATS, AND EQUIPMENT BASED ON A PIGGYBACK OF THE **FLORIDA SHERIFFS** ASSOCIATION COOPERATIVE PURCHASING PROGRAM CONTRACT NO. FSA25-VEF19.0; AUTHORIZING PAYMENT IN AN AMOUNT NOT TO EXCEED \$985,124.00; PROVIDING THE CITY MANAGER WITH AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE PROVIDING FOR AN EFFECTIVE DATE THIS RESOLUTION; (REOUESTED BY INTERIM CITY MANAGER KENNIE HOBBS, JR).

WHEREAS, pursuant to the City's Procurement Code, the City of Lauderhill ("City") may purchase vehicles and other equipment through the piggyback process; and

WHEREAS, the City of Lauderhill wishes to purchase two (2) fire rescue vehicles through the Florida Sheriffs Association Cooperative Purchasing Program; and

WHEREAS, the City Commission of the City of Lauderhill believes it is in the best interest to purchase two (2) fire rescue vehicles via piggyback through the Florida Sheriffs Association Cooperative Purchasing Program.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. That the City Commission of the City of Lauderhill authorizes an agreement with Matheny Motor Company for the purchase of two (2) fire rescue vehicles and related equipment through piggyback from the Florida Sheriffs Association Cooperative Purchasing Program Contract No. FSA25-VEF19.0, in an amount not to exceed \$985,124.00.

SECTION 2. That the City Manager is authorized to do all things to effectuate this Resolution.
