

RESOLUTION NO. 24R-09-197

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING; AUTHORIZING THE PIGGYBACK OF THE FLORIDA SHERIFF ASSOCIATION`S CONTRACT (FSA23-EQU21.0) TO APPROVE THE PURCHASE OF TWO (2) 61" TIGER CAT II 26HP KAW EFI AND 61" VELOCITY HURRICANE MULCH KITS FOR CITYWIDE LANDSCAPE MAINTENANCE FROM GREEN THUMB PALM BEACH; PROVIDING FOR PAYMENT IN THE TOTAL AMOUNT NOT TO EXCEED \$20,707.60 FROM BUDGET CODE NUMBER 450-927-06440; PROVIDING FOR AN EFFECTIVE DATE, (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the Florida Sheriff Association`s has solicited bids (FSA EQU21.0) for the purchase of Heavy Equipment; and

WHEREAS, the City of Lauderhill wishes to approve the purchase of the heavy equipment from Green Thumb Palm Beach for use by the City based upon the bids solicited by the Florida Sheriff`s Association for citywide landscape maintenance; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The waiver of competitive bidding is hereby approved.

SECTION 2. The purchase of various heavy equipment to include two (2) 61" Tiger Cat II 26HP KSAW EFI and 61" velocity hurricane mulch kits from Green Thumb Palm Beach for citywide landscape maintenance, based upon the bids solicited by the Florida Sheriff`s Association (FSA EQU21.0), a copy of which is attached hereto, is hereby approved.

SECTION 3. Payment in the total amount not to exceed \$20,707.60 shall be made from Budget Code Number 450-927-06440.

SECTION 4. This Resolution shall take effect immediately upon its passage.
