A RESOLUTION IS REQUIRED FROM THE CITY COMMISSION TO APPROVE FY 2018-2019 FIRST AMENDMENT HOME REHABILITATION INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF LAUDERHILL.

Need:

ACTION IS REQUIRED TO OBTAIN COMMISSION APPROVAL PRIOR TO EXECUTING THE 2018-2019 FIRST AMENDMENT INCREASING FUNDING DISTRIBUTION FROM \$108,042 TO \$112,803.

Summary Explanation/ Background:

THE CITY OF LAUDERHILL AND BROWARD COUNTY ENTERED INTO THE 2018-2019 AGREEMENT FOR THE PURPOSE OF HOUSING REHABILITATION ON JULY 16, 2019. THE CITY OF LAUDERHILL HAS A BALANCE OF \$4,761 IN UNENCUMBERED FUNDING FOR FISCAL YEAR 2015-2016. THE CURRENT BALANCE IS INSUFFICIENT TO ASSIST A HOUSEHOLD. STAFF IS REQUIRED TO ROLL FUNDING INTO THE CURRENT FISCAL YEAR TO EXPEND AND CLOSEOUT THE 2015-2016 AGREEMENT.
