RESOLUTION NO. 24R-12-291: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL ACCEPTING, APPROVING AND ADOPTING THE CITY OF LAUDERHILL' S CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER) FOR FISCAL YEAR 2023-2024; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER, KENNIE HOBBS, JR.)

Request Action:

A resolution is requested from the City Commission to approve the City of Lauderhill's Fiscal Year 2023-2024 Consolidated Annual Performance Evaluation Report (CAPER).

Need Summary Explanation/ Background:

Commission approval is required prior to the submittal to satisfy the United States Department of Housing and Urban Development (HUD) regulations for Participating Jurisdictions receiving federal funding.

Cost Summary/ Fiscal Impact:

The CAPER is an annual evaluation and performance report of the City's approved Fifth Year Action Plan. It provides details on accomplishments made towards meeting the goals outlined in the Five (5) Year Consolidated Plan for the Community Development Block Grant (CDBG) program, administered by the City. Fiscal Year (FY) 2024 (Program Year -PY 2023) is the fourth year of the 2020-2024 Consolidated Plan period, which runs from October 1, 2023 to September 30, 2024.

Approved projects for FY 2023-2024 included public service, neighborhood facilities improvements, affordable housing preservation via rehab activities targeted towards eligible elderly households, and program administration. Additionally, the City continued to make critical improvements to public facilities and park amenities as necessary. Funding utilized during this fiscal year targeted and benefited low- and moderate-income persons. The City's efforts were consistent with the National Objectives of this federal CDBG program.
