Request Action:

A resolution is requested from the City Commission to waive competitive bidding requirements in accordance with section 2-144 of the City's code of ordinance and approve the purchase and installation of emergency equipment for ten (10) police vehicle not to exceed \$288,683.56.

Action is needed to allow the City to purchase and install emergency equipment from Strobes-R-US for street deployment of the new vehicles purchased for use by the Lauderhill Police Department,
