

RESOLUTION NO. 19R-10-232

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; AUTHORIZING THE PURCHASE AND INSTALLATION, SERVICE, AND REPAIR OF OVERHEAD ROLL-UP DOORS, GRILLS, AND HYDRAULIC BI-FOLD DOORS FROM THE VARIOUS VENDORS LISTED, ON AN AS NEEDED BASIS, BASED UPON THE SOUTHEAST FLORIDA GOVERNMENTAL COOPERATIVE GROUP AND THE BIDS SOLICITED BY THE CITY OF DEERFIELD BEACH ACTING AS LEAD AGENCY (ITB 2016-17-31); PROVIDING FOR PAYMENT IN THE TOTAL AMOUNT NOT TO EXCEED \$50,000.00 FROM BUDGET CODE NUMBER 001-313-4615; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Deerfield Beach has already solicited bids (Bid 2016-17-31) and awarded a contract to utilize the various vendors indicated for the purchase, installation, service, and repair of overhead Roll-Up doors, Grills, and Hydraulic Bi-Fold Doors from the various vendors listed; and

WHEREAS, the City of Lauderhill wishes to award the contract based upon the bids solicited by the City of Deerfield Beach for the installation, service, and repair of overhead Roll-Up doors, Grills, and Hydraulic Bi-Fold Doors; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract for the installation, service, and repair of overhead Roll-Up doors, Grills, and Hydraulic Bi-Fold Doors, based upon Southeast Florida Governmental Cooperative Group and the bids solicited by the City of Deerfield Beach acting as Lead Agency (Bid 2016-17-31), a copy of which is attached hereto and incorporated by reference, to the following vendors is hereby approved:

1. Above All Garage Door of South Florida.
2. Best Garage Doors, Inc.
3. Coast to Coast Garage Door, LLC.
4. Door Systems of South Florida.

Section 3. Providing that payment shall be made on an as needed basis in a total

amount not to exceed \$50,000.00 from Budget Code Number 001-313-4615.

Section 4. This Resolution shall take effect immediately upon its passage.
