

RESOLUTION NO. 25R-12-240

A RESOLUTION OF THE CITY OF LAUDERHILL, FLORIDA, SUBMITTING TO REFERENDUM QUESTIONS TO THE QUALIFIED ELECTORS OF THE CITY OF LAUDERHILL, FLORIDA AUTHORIZING THE ISSUANCE OF NOT EXCEEDING SIXTY-FIVE MILLION DOLLARS (\$65,000,000) AGGREGATE PRINCIPAL AMOUNT (WITHOUT REGARD TO ORIGINAL ISSUE DISCOUNT OR PREMIUM) OF GENERAL OBLIGATION BONDS OF THE CITY OF LAUDERHILL, FLORIDA, IN ONE OR MORE SERIES, FOR CAPITAL IMPROVEMENTS; PROVIDING FOR NOTICE OF THE BOND REFERENDUM ELECTION TO BE PUBLISHED IN ACCORDANCE WITH THE CHARTER AND CODE OF ORDINANCES OF THE CITY OF LAUDERHILL, FLORIDA, AND CHAPTER 100, FLORIDA STATUTES, AS AMENDED; PROVIDING FOR THE PLACE AND PLACES WHERE THE BOND REFERENDUM ELECTION IS TO BE HELD; PROVIDING FOR AUTHORIZATION AND DIRECTION TO THE CITY CLERK TO PERFORM CERTAIN DUTIES AND FUNCTIONS IN ACCORDANCE WITH THIS RESOLUTION; PROVIDING FOR OTHER MATTERS IN CONNECTION WITH THE FOREGOING; PROVIDING FOR SEVERABILITY AND REPEALING CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Lauderhill, Florida (the "City") has developed a list of capital improvements located or to be located within the boundaries of the City which may be financed (or the cost of which may be reimbursed), all or in part, with proceeds of its general obligation bonds and other legally available funds (the "GOB Projects List"). The City undertook various efforts to develop the GOB Projects List, including, without limitation, (i) the City Commission of the City of Lauderhill, Florida (the "City Commission") tasked City staff with identifying capital improvements for which funding sources had not yet been determined, all or in part; and (ii) soliciting input from citizens and residents in the City, including, without limitation through public workshops, as part of the process of developing the GOB Projects List.

WHEREAS, the City has determined that there is a need for capital projects to be constructed in the City, including but not limited to, (i) a new police public safety building, license plate reader system, fire station improvements, public safety building and facilities hardening, and a network infrastructure system ("Public Safety Projects"), (ii) various city-wide parks improvements, including parks building and facilities hardening ("Parks Improvements Projects"), and (iii) various city-wide road improvements, a parking garage, and walls along various city-wide public roadways ("Transportation and Roadway Projects"). The Public Safety Projects, the Parks Improvements Projects, and the Transportation and Roadway Projects are collectively referred to herein as, the "Projects," all as further described on Exhibit B attached hereto; and

WHEREAS, the City Commission finds that it is necessary and desirable to acquire, construct, renovate, replace and equip the Projects; and

WHEREAS, it is a municipal and public purpose to pay the cost of the Projects, all or in part, through the issuance of general obligation bonds of the City, payable from ad valorem taxes, as hereinafter provided, to serve the health, safety, and welfare of all the citizens and residents of Lauderhill, Florida; and

WHEREAS, the City Commission hereby determines that it serves a paramount public purpose that the Projects be acquired, constructed, renovated, replaced and equipped and that it is in the best interest of the City to issue general obligation indebtedness to finance costs of the Projects; and

WHEREAS, the City Commission finds that the Projects benefit the City's citizens; and

WHEREAS, as a condition to the issuance of the Bonds, it is necessary to call and hold the Referendum to determine whether a majority of the qualified electors of the City voting in said Referendum approve the issuance of such Bonds, with the issuance of such Bonds being separately considered for approval, as provided in Section 6 hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. AUTHORITY FOR THIS RESOLUTION. This Resolution is adopted pursuant to the Constitution and laws of the State of Florida, Chapter 166, Florida Statutes, as amended, Chapter 100, Florida Statutes (the "Election Code"), the Charter and the Code of Ordinances of the City, and other applicable provisions of law (hereinafter collectively referred to as the "Act").

SECTION 2. FINDINGS. The City Commission hereby finds and determines that the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and adopts the same as its findings and determinations and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 3. INTENT TO ISSUE BONDS. Subject to a referendum provided for herein (the "Bond Referendum Election") and pursuant to subsequent proceedings of the City, the City intends to authorize the issuance of three separate general obligation bonds of the City, in three separate ballot questions as provided in Section 6 hereof, in an aggregate principal amount (without regard to original issue discount or premium) totaling not exceeding Sixty-five Million Dollars (\$65,000,000) (collectively, the "Bonds"), each in one or more series, each as either tax-exempt or taxable, each maturing at such time or times not exceeding thirty (30) years from their

respective date or dates of issue, as may be determined by the City Commission, and each bearing interest at a rate or rates per annum not exceeding the maximum lawful rate allowed by law, as shall be determined at the time of sale thereof, and each to be payable from unlimited ad valorem taxes, for the purpose of providing funds, together with any other available funds, for paying the cost of the Projects. Proceeds from the Bonds shall be applied to costs of the Projects.

Nothing in this Resolution shall be deemed to require the City to (i) issue any or all of the general obligation bonds to fund the Public Safety Projects (the "Public Safety General Obligation Bonds"), if same are approved at the Referendum and/or to apply proceeds of the Public Safety General Obligation Bonds (or any series thereof), if issued, to finance any specific components of the Public Safety Projects; (ii) issue any or all of the general obligation bonds to fund the Parks improvements Projects (the "Parks Improvements General Obligation Bonds"), if same are approved at the Referendum and/or to apply proceeds of the Parks Improvements General Obligation Bonds (or any series thereof), if issued, to finance any specific components of the Parks Improvements Projects; and/or (iii) issue any or all of the general obligation bonds to fund the Transportation and Roadway Projects (the "Transportation and Roadway General Obligation Bonds"), if same are approved at the Referendum and/or to apply proceeds of the Transportation and Roadway General Obligation Bonds (or any series thereof), if issued, to finance any specific components of the Transportation and Roadway Projects.

The City may, in its sole discretion, by official action evidenced by a resolution or ordinance of the City Commission adopted or enacted from time to time, modify or amend all or any portion of the items included in the Public Safety Projects, Parks Improvements Projects, and/or Transportation and Roadway Projects to (1) delete one or more of the listed items if the

City determines it is not feasible or is otherwise not in the best interests of the City to pursue or (2) substitute or modify one or more of the listed items, if the City determines such substitution or modification better serves City purposes, provided such modified or substituted facility, improvement or equipment shall be included in the City's five-year capital improvement program, as adopted from time to time, and be related to (i) police and/or fire and/or other public safety services with respect to the Public Safety Projects, (ii) parks, community centers, amphitheaters, pavilions, ballfields, other recreational and/or cultural and related purposes, including, without limitation, related parking, with respect to the Parks Improvements Projects, and (iii) roadway improvements and/or related landscaping, parking and walls adjacent to public roadways with respect to the Transportation and Roadway Projects.

SECTION 4. BOND REFERENDUM ELECTION. A Bond Referendum Election of the qualified electors in the City is hereby called and authorized to be held on March 10, 2026, between the hours of 7:00 a.m. and 7:00 p.m. to determine whether or not the issuance of (i) Public Safety General Obligation Bonds in an aggregate principal amount (without regard to original issue discount or premium) totaling not to exceed Nine Million Five Hundred Thousand Dollars (\$9,500,000) to finance the cost of the Public Safety Projects, (ii) Parks Improvements General Obligation Bonds in an aggregate principal amount (without regard to original issue discount or premium) totaling not to exceed Thirty-Four Million Dollars (\$34,000,000) to finance the cost of the Parks Improvements Projects, and/or (iii) Transportation and Roadway General Obligation Bonds in an aggregate principal amount (without regard to original issue discount or premium) totaling not to exceed Twenty-One Million Five Hundred Thousand Dollars (\$21,500,000) to finance the cost of the Transportation and Roadway Projects shall be approved by such qualified

electors. All qualified electors in the City shall be entitled and permitted to vote in the Bond Referendum Election. The places of voting for the Referendum Bond Election shall be designated by the Supervisor of Elections of Broward County, Florida (the "Supervisor of Elections").

The Supervisor of Elections shall hold, administer and conduct the Bond Referendum Election in the manner prescribed by law for holding special elections or referendum in the City and consistent with the City's written agreement with the Supervisor of Elections. The City Clerk of the City (the "City Clerk") is directed to take all necessary measures to conduct the Bond Referendum Election in accordance with applicable law. The results shall be certified to the Department of State in accordance with Section 100.351, Florida Statutes. All procedures and requirements of the Act shall be complied with for the purpose of conducting the computation of ballots and completion of bond referendum procedures.

The City Clerk is hereby designated and appointed as the official representative of the City Commission in all transactions with the Supervisor of Elections in relation to matters pertaining to the use of the registration books and the holding of said Bond Referendum Elections.

SECTION 5. NOTICE OF BOND REFERENDUM. Notice of the Bond Referendum Election, including the time and location of polling places contemplated herein all in accordance with the Code of Ordinances of the City of Lauderhill, Florida, as well as the Election Code, as amended, shall be published in a newspaper of general circulation in the City, at least twice, once in the fifth week and once in the third week prior to the week in which the Bond Referendum Election is held, the date of first publication in said newspaper to be at least thirty (30) days before said Bond Referendum Election, in substantially the form attached hereto as Exhibit A and in the

manner provided in Section 100.342, Florida Statutes. The City Clerk is hereby authorized and directed to publish such notice.

SECTION 6. OFFICIAL BALLOT. The ballot questions for voting in the Bond Referendum Election shall be in substantially the following forms and provisions of this Resolution shall be deemed incorporated in each of said ballot questions:

SECTION 7. EFFECT OF RESULTS.

The return of the votes cast at said Bond Referendum Election shall be made to and canvassed by the Broward County Canvassing Board and the Broward County Canvassing Board shall declare the result. If a majority of the votes cast at such Bond Referendum Election in respect to the issuance of (i) Public Safety General Obligation Bonds shall be "For Bonds," such issuance shall be approved, and then the Public Safety General Obligation Bonds, the issuance of which shall be thereby approved, may be issued as hereafter provided by the City Commission and the Charter; (ii) Parks Improvements General Obligation Bonds shall be "For Bonds," such issuance shall be approved, and then the Parks Improvements General Obligation Bonds, the issuance of which shall be thereby approved, may be issued as hereafter provided by the City Commission and the Charter; and (iii) Transportation and Roadway General Obligation Bonds shall be "For Bonds," such issuance shall be approved, and then the Transportation and Roadway General Obligation Bonds, the issuance of which shall be thereby approved, may be issued as hereafter provided by the City Commission and the Charter. If less than a majority of the votes cast at said Bond Referendum Election with respect to issuance of (i) the Public Safety General Obligation Bonds shall be "Against Bonds," such issuance shall be defeated, and no Public Safety General Obligation Bonds for such Public Safety Projects shall be issued pursuant to this Resolution; (ii) the Parks Improvements General Obligation Bonds shall be "Against Bonds," such issuance shall be defeated, and no Parks Improvements General Obligation Bonds for such Parks Improvements Projects shall be issued pursuant to this Resolution; and/or (iii) the Transportation and Roadway General Obligation Bonds shall be "Against Bonds," such issuance shall be defeated, and no Transportation and Roadway General

Obligation Bonds for such Transportation and Roadway Projects shall be issued pursuant to this Resolution.

The approval or defeat of a particular ballot question considered at the Bond Referendum Election shall not impact the approval or defeat of any other ballot question considered at the Bond Referendum Election. If approved at the Bond Referendum Election, the appropriate representatives of the City are authorized to seek judicial validation by the Circuit Court in and for Broward County, Florida of the Bonds so approved.

SECTION 8. LANGUAGES. To the extent required by law, the ballot questions at the Referendum and the notices of the Referendum shall be published in both the English and Spanish languages.

SECTION 9. SEVERABILITY OF INVALID PROVISION. Should any section or provision of this Resolution or portion hereof, any paragraph, sentence, or word be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the remainder of this Resolution.

SECTION 10. REPEAL OF INCONSISTENT INSTRUMENTS. That all resolutions or parts of resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.
