

**RESOLUTION NO. 25R-03-76**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE ALLOCATION OF \$25,000.00 TO THE LAUDERHILL CHAMBER OF COMMERCE, INC., FOR ECONOMIC DEVELOPMENT AND BUSINESS RETENTION SERVICES; PROVIDING FOR TERMS AND CONDITIONS; PROVIDING FOR COMPENSATION IN THE TOTAL AMOUNT OF \$25,000.00 FOR THIS FISCAL YEAR FROM THE APPROPRIATE BUDGET CODE NUMBER; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER KENNIE HOBBS, JR.).**

WHEREAS, the Lauderhill Regional Chamber of Commerce (“LRCC”) plays a vital role in strengthening Lauderhill’s business community and fostering economic growth; and

WHEREAS, LRCC has submitted a proposal to establish a formal partnership with the City of Lauderhill which proposes to, among other things, expand support services for local businesses, aiding in retention, growth, and sustainability, hereinafter “Proposal”; and

WHEREAS, the City Commission has determined it is in the best interests of its residents and business community to enter into an agreement with LRCC with funding in the amount of \$25,000, help ensure continued support for local businesses and further strengthen the City’s economic development initiatives.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The City Commission, having reviewed the Proposal, hereby authorizes the Interim City Manager and other appropriate staff, to enter into an agreement with LRCC.

SECTION 2. The City Commission approves funding up to \$25,000, with payment to be paid as structured in accordance with the Agreement from budget code number 001-101-8117.

SECTION 3. This Resolution shall take effect immediately upon its passage.
