WHEREAS, J&D Concrete Works Corp. submitted a bid and response to Bid No.2025-041 to provide for asphalt resurfacing and swale reconfiguration within the City right-of-ways; and

WHEREAS, based on the evaluation of bids, staff recommends awarding the bid to J&D Concrete Works Corp.
