City Commission approving the renewal of the Small Government Enterprise Agreement (SGEA) with Environmental Systems Research Institute (ESRI) which is a sole source provider of the Geographic Information System (GIS) mapping application for citywide use for a period of three (3) years.

The GIS is used citywide by multiple divisions/departments to provide locational analysis, crime analysis, and various other mapping tools and to aid in capital improvement recommendations based on asset management and maintenance tracking.
