

RESOLUTION NO. 25R-09-192

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AWARING BID NO. 2025-047 – CITY HALL PARKING LOT TO STANFORD CONSTRUCTION, CO., TO CONSTRUCT A NEW PARKING LOT, IMPROVE DRAINAGE INFRASTRUCTURE, LANDSCAPING, AND LIGHTING AT THE CITY HALL BASED UPON THE TABULATION OF BID RESULTS; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH STANFORD CONSTRUCTION, CO., IN AN AMOUNT NOT TO EXCEED \$1,185,211.75 FROM BUDGET CODE NUMBER 450-925-06592; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY ENGINEER, J. MARTIN CALA P.E. AND CITY MANAGER, KENNIE HOBBS JR.).

WHEREAS, the City of Lauderhill issued Invitation to Bid #2025-047- City Hall Parking Lot to hire a contractor to construct a new parking lot and to improve infrastructure, landscape and lighting at City Hall; and

WHEREAS, three contractors responded to the bid, with Stanford Construction, Co., submitting the lowest responsible and responsive bid; and

WHEREAS, based on the tabulation of bid results, staff recommends awarding Bid #2025-047 to Stanford Construction, Inc., and authorizing the City Manager to enter into a construction agreement with Stanford Construction, Co., in an amount not to exceed \$1,185,211.75.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The above recitations are true and hereby incorporated herein.

SECTION 2. The City Commission awards Invitation to Bid #2025-047 to Stanford Construction, Co., to construct a new parking lot and improve infrastructure, landscape and lighting at City Hall and further authorizes the City Manager to enter into an agreement with Stanford Construction, Co., in an amount not to exceed \$1,185, 211.75.

SECTION 3. Payment shall be made from budget code number 450-925-06592.

SECTION 4. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 5. This Resolution shall take effect immediately upon its passage.
