A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL PROVIDING PUBLIC NOTICE OF AND APPROVING AND ACCEPTING THE FIRST AMENDMENT TO THE 2017 EDWARD BYRNE JUSTICE ASSISTANCE LOCAL SOLICITATION GRANT (JAG) MEMORANDUM OF UNDERSTANDING (MOU) IN THE NET AMOUNT OF \$33,159.06 AFTER ADMINISTRATIVE FEES; APPROVING EXECUTION OF THE SUB-RECIPIENT AGREEMENT AND OTHER NECESSARY DOCUMENTATION; PROVIDING THAT NO MATCHING FUNDS ARE REQUIRED; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, The City of Lauderhill previously passed Resolution No. 19R-02-33 approving and accepting the 2017 JAG Grant MOU; and

WHEREAS, the Department of Justice has requested changes to the previously approved MOU as reflected in the attached First Amendment to the JAG MOU;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The City of Lauderhill hereby provides public notice of, approves and accepts the First Amendment to the 2017 Edward Byrne Justice Assistance Local Solicitation Grant (JAG) Memorandum of Understanding (MOU) in the net amount of \$33,159.06, after administrative fees, a copy of which is attached hereto and incorporated herein.

Section 2. The City of Lauderhill hereby authorizes the appropriation of funds to the individual revenue and expenditure accounts.

Section 3. The City Manager and all appropriate City officials including the Police Chief are authorized to execute the First Amendment to the JAG Memorandum of Agreement (MOU), the initial MOU, the Subrecipient Agreement, as well as any other documents necessary to fulfill the terms of this Resolution. Any documents that may have required earlier execution to meet necessary time deadlines are approved retroactively.

Section 4. This Resolution shall take effect immediately upon its passage.
