ORDINANCE NO. 250-09-138

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AMENDING THE CITY'S CODE OF ORDINANCES, APPENDIX G, "FRANCHISES", ARTICLE III, "GARBAGE, REFUSE AND TRASH, EXHIBIT A, ATTACHED HERETO, BY AMENDING THE RATE SCHEDULE OF FEES TO GO INTO EFFECT BY THE SERVICE PROVIDER ON OCTOBER 1, 2025; PROVIDING FOR CONFLICTS, SEVERABILITY, AND CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).

WHEREAS, the City of Lauderhill entered into a franchise agreement with Waste Management, Inc. of Florida in 2016; and

WHEREAS, under the Agreement Waste Management is able to increase its franchise fees for certain types of services; and

WHEREAS, the parties have agreed to the new franchise fees for garbage, refuse and trash, as set forth in the Franchise Fee Table, attached as **Exhibit A**, said fees to be in effect on October 1, 2025.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>SECTION 1.</u> That the above recitations are true and incorporated herein.

<u>SECTION 2.</u> That Appendix G, Franchises, Article III, "Garbage, Refuse and Trash", is hereby amended as set forth in **Exhibit A**, attached hereto (<u>underline</u> is added; strike through is deleted).

<u>SECTION 3.</u> <u>Conflicts.</u> That all Ordinances or parts of Ordinances, Resolutions or parts of resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

<u>SECTION 4.</u> <u>Severability</u>. Should any section, provision, paragraph, sentence, clause or word of this Ordinance or portion hereof be held or declared by any court of competent jurisdiction to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remaining portions or applications of this Ordinance.

SECTION 5. Codification. It is the intention of the City Commission that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances of the City of Lauderhill, Florida, and that the sections of this Ordinance may be renumbered or relettered and the word "Ordinance" may be changed to "section", "article" or such other word or phrase in order to accomplish such intentions.
