

RESOLUTION NO. 25R-09-193

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AWARDING BID NO. 2025-048 - INVERRARY DRIVE CORRIDOR RESURFACING TO ROSE PAVING, LLC, TO RESURFACE THE ROADWAY ALONG INVERRARY DRIVE AND PROVIDE OTHER ROADWAY IMPROVEMENTS BASED UPON THE TABULATION OF BID RESULTS; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH ROSE PAVING, LLC ROSE PAVING, LLC, IN AN AMOUNT NOT TO EXCEED \$501,878.08 FROM BUDGET CODE NUMBER 450-925-06947; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY ENGINEER, J. MARTIN CALA P.E. AND CITY MANAGER, KENNIE HOBBS JR.).

WHEREAS, the City of Lauderhill issued Invitation to Bid #2025-048 – Inverrary Drive Corridor Resurfacing, to hire a contractor to resurface the roadway along Inverrary Drive with asphalt and to provide other roadway improvements; and

WHEREAS, five contractors responded to the bid, with Rose Paving, LLC, submitting the lowest responsible and most responsive bid; and

WHEREAS, based on the tabulation of bid results, staff recommends awarding Bid #2025-048 to Rose Paving, LLC, and authorizing the City Manager to enter into a construction agreement with Rose Paving, LLC, in an amount not to exceed \$501,878.08.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The above recitations are true and hereby incorporated herein.

SECTION 2. That the City Commission of the City of Lauderhill awards Invitation to Bid #2025-048 to Rose Paving, LLC, to resurface the roadway along Inverrary Drive with asphalt and to provide other roadway improvements and further authorizes the City Manager to enter into an agreement with Rose Paving, LLC, in an amount not to exceed \$501,878.08.

SECTION 3. Payment shall be made from budget code number 450-925-06947.

SECTION 4. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 5. This Resolution shall take effect immediately upon its passage.
