AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL. FLORIDA. BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>Section 1.</u> The six-month budget review of revenue and expenditure amendments for Fiscal Year 2025 in the total adjustment amount of \$14,197,292.00, is hereby approved.

- <u>Section 2.</u> The Supplemental Appropriation of additional revenues and expenditures in the total amount of \$3,934,292.00 to the Fiscal Year 2025 budget to transfer funds incorporated by reference is hereby approved.
- <u>Section 3.</u> The Interdepartmental Budget Adjustment in the amount of \$9,919,700.00 to the Fiscal Year 2025 budget to transfer funds among various budgeted line items, a copy of which is attached hereto and incorporated by reference, is hereby approved.
- Section 4. The Capital Budget Adjustment in the amount of \$343,000.00 to the Fiscal Year 2025 budget to transfer funds among various budgeted line items, a copy of which is attached hereto and incorporated by reference, is hereby approved.
- <u>Section 5.</u> That the total budget adjustments in the amount of \$14,197,292.00, is hereby approved.
- <u>Section 6.</u> All ordinances or parts of ordinances, all resolutions or parts of resolutions in conflict herein be the same are hereby repealed as to the extent of such conflict.

Section 7. This ordinance shall take effect immediately upon its adoption.
