A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE WAIVER OF COMPETITIVE BIDDING; APPROVING THE AWARD OF BID TO CHENY BROTHERS, INC. FOR EMERGENCY FOOD DELIVERY SERVICES DURING DECLARED STATE OF EMERGENCIES BASED UPON THE SOLICITATION BY THE STATE OF FLORIDA DEPARTMENT OF CORRECTIONS (#C2808) ALTERNATE CONTRACT SOURCE NO. 93131607-15-ACS IN AN AMOUNT NOT TO EXCEED \$50,000.00 ON AN AS-NEEDED BASIS; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBER(S); PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans or solicitations without bids when the best interests of the City would be served; and

WHEREAS, the State of Florida Department of Corrections, did a Solicitation (#C2808) for Emergency Food Delivery Services, Alternate Contract Source No. 93131607-15-ACS; and

WHEREAS, the City of Lauderhill has reviewed the solicitation by the State of Florida Department of Corrections and wishes to approve the award of bid to Cheny Brothers, Inc. for emergency food delivery services during declared State of Emergencies on an as needed basis pursuant to that contract; and

WHEREAS, the City Commission has determined that the award for Emergency Food Service during State of Emergencies, as set forth herein would serve the best interests of the City of Lauderhill;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of bid to Cheny Brothers, Inc. for Emergency Food Delivery Service based upon the solicitation (#C2808) by the State of Florida Department of Corrections for Emergency Food Delivery Services, Alternate Contract Source No. 93131607-15-ACS on an as-needed basis, a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment in an amount not to exceed \$50,000.00, to be used on an as-needed basis, shall be made from the appropriate Budget Code Number(s).

Section 4. This Resolution shall take effect immediately upon its passage.
