## WARRANTY DEED

THIS INDENTURE, made this \_\_\_\_ day of \_\_\_\_\_, 2024, between the CITY OF LAUDERHILL, a Florida municipal corporation organized under and in accordance with the laws of the State of Florida, whose post office address is 5581 West Oakland Park Blvd., Lauderhill, Florida 33313 of the County of Broward, State of Florida (“GRANTOR”) and the LAUDERHILL COMMUNITY REDEVELOPMENT AGENCY, a public body corporate and politic formed pursuant to Florida Statutes, Chapter 163 and City of Lauderhill Ordinance Nos. Ord. 04O-07-153 and Ord. 04O-07-154, whose address is 5581 West Oakland Park Blvd., Lauderhill, Florida 33313 of the County of Broward and State of Florida (“GRANTEE”).

WITNESSETH, that this subject property is being conveyed from GRANTOR to GRANTEE for Ten Dollars and No Cents (\$10.00) and other good and valuable to said GRANTOR in hand paid by said GRANTEE, the receipt of which is hereby acknowledged, such that said GRANTOR has granted, bargained and sold or otherwise conveyed to the said GRANTEE, and GRANTEE's heirs and assigns forever, the following described land, situate, lying and being in Broward County, Florida, to-wit:

**A portion of the Southeast ¼ Section 31, Township 49 South, Range 42 East, Broward County, Florida being and more particularly described as:**

**Commencing at the Southeast corner of the North ½ of the South ½ of the Northeast ¼ of the Southeast ¼ of said Section 31; thence North 1°04'30" West, along the East line of said Southeast ¼ of a distance of 50 feet; thence South 88°45'25" West, a distance of 255.28 feet to the Southeast corner of “LARKDALE REPLAT”, as recorded in Plat Book 58, Page 42, of the Public Records of Broward County, Florida; thence North 1°06'48" West, along the East line of said “LARKDALE REPLAT, a distance of 156.42 feet to the Point of Beginning of this description; thence continue North 1°06'48" West along the said East line of “LARKDALE REPLAT”, a distance of 355 feet; thence North 88°58'10" East, a distance of 202.62 feet; thence South 1°04'30" East parallel with the 53 feet West of the East line of said Southeast ¼ of Section 31 a distance of 355 feet; thence South 88°58'10" West, a distance of 202.38 feet to the Point of Beginning.**
