RESOLUTION NO. 25R-02-42: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPOINTING MICHELLE MCKOY BY COMMISSIONER JOHN T. HODGSON AND STEPHANIE WHITFIELD BY VICE MAYOR SARAI "RAY" MARTIN TO SERVE AS MEMBERS OF THE PUBLIC ART COMMITTEE FOR THE VACANT UNEXPIRED FOUR (4) YEAR TERMS TO EXPIRE NOVEMBER 2028 OR CONCURRENT WITH THE COMMISSIONER SEAT, WHICHEVER OCCURS FIRST; AND PROVIDING FOR AN EFFECTIVE DATE.

Request Action:

Appointments to the Public Art Committee must be made due to a number of expirations in term and the election of new Commissioners to specific seats.

Need Summary Explanation/ Background:

The Code of Ordinances states that when a Commissioner's term ends or they leave office, any appointments they made, which have not otherwise expired, will automatically expire 60 days after their successor takes office unless the new Commissioner approves extending the existing appointment.

The appointment of Crystal Pressey as regular board member, in association with seat 1, expired November 2024.

Commissioner John T. Hodgson has selected Michelle McKoy to be appointed to the seat for the remainder of an unexpired term that lasts four (4) years, to expire November 2028 or concurrent with the Commissioner seat, whichever shall occur first.

The appointment of Stephenie Whitfield as regular board member, in association with seat 3, expired November 2024.

Vice Mayor Sarai "Ray" Martin has approved the reappointment of Stephenie Whitfield to the seat for the remainder of an unexpired term that lasts four (4) years, to expire November 2028 or concurrent with the Commissioner seat, whichever shall occur first.
