DESCRIPTION:

THE NORTH 5.00 FEET OF THE SOUTH 20.00 FEET OF THE EAST 150.00 FEET OF THAT CERTAIN PARCEL OF LAND AS DESCRIBED IN THE WARRANTY DEED RECORDED UNDER INSTRUMENT NUMBER 114805828 OF THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA. BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT 50 FEET WEST OF AND 3955.75 FEET NORTH OF THE SOUTHEAST CORNER OF THE SW 1/4 OF SECTION 6, TOWNSHIP 50 SOUTH, RANGE 42 EAST, FOR A **POINT OF BEGINNING**; THENCE RUN WEST 850.07 FEET ALONG A LINE PARALLEL TO THE SOUTH LINE OF SAID SECTION 6 AND FORMING AN ANGLE OF 89 DEGREES 18' 47" IN THE NORTHWEST QUADRANT AS MEASURED FROM A LINE PARALLEL TO THE EAST LINE OF THE NW 1/4 OF SAID SECTION 6; THENCE RUN NORTH ALONG A LINE PARALLEL TO AND 900 FEET WEST OF SAID EAST LINE OF THE NW 1/4 FOR A DISTANCE OF 563.07 FEET, MORE OR LESS, TO A POINT 870 FEET SOUTH OF THE NORTH LINE OF SAID SECTION 6; THENCE RUN EAST 850.03 FEET, MORE OR LESS, ALONG A LINE PARALLEL TO SAID NORTH LINE OF SECTION 6, TO THE POINT 50 FEET WEST OF THE EAST LINE OF SAID NW 1/4 OF SECTION 6; THENCE RUN SOUTH 565.28 FEET, MORE OR LESS, ALONG A LINE 50 FEET WEST OF AND PARALLEL TO SAID EAST LINE OF THE NW 1/4 TO THE **POINT OF BEGINNING**.

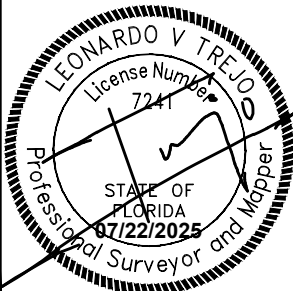

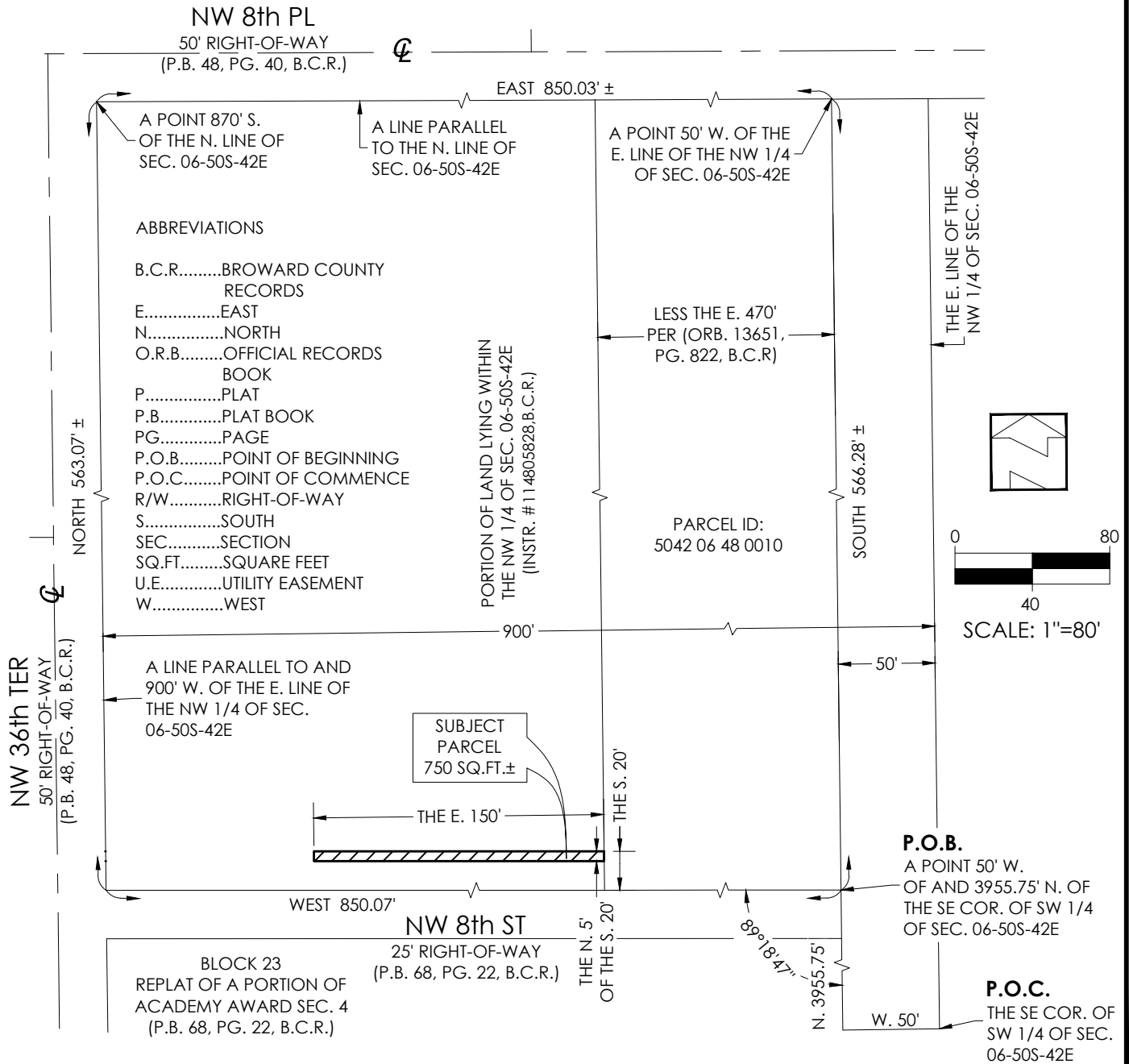
