#### Need Summary Explanation/ Background:

ACTION IS NEEDED TO AWARD BID 2025-041 TO J&D CONCRETE WORKS CORP TO MILL AND RESURFACE LOCAL ROADS AND RECONFIGURE SWALES TO ORIGINAL CONDITIONS AND INSTALL EXFILTRATION TRENCHES. THIS ACTION IS NEEDED TO IMPROVE THE ASPHALT SURFACE IN ACCORDANCE TO THE CITYWIDE PAVEMENT CONDITION SURVEY AND MINIMIZE LOCALIZED FLOOD CONDITIONS THROUGHOUT THE NORTHWEST NEIGHBORHOOD IN ACCORDANCE TO THE CITYWIDE STORMWATER MANAGEMENT AND FLOOD PROTECTION MASTER PLAN. THE WORK INCLUDES, BUT IS NOT LIMITED TO THE FOLLOWING: ROADWAY ASPHALT RESURFACING AND MARKING, AND THE REMOVAL AND DISPOSAL OF EXISTING GRASS, LANDSCAPE MATERIAL AND TOP SOIL, RECONFIGURATION/REGRADING SWALES, CONSTRUCTION OF EXFILTRATION TRENCHES, INSTALL CATCH BASIS WHERE APPLICABLE AND THE RESTORATION OF DISTURBED AREAS INCLUDING SIDEWALK REPAIRS, IRRIGATION REPAIRS, AND SOD REPLACEMENT AS NECESSARY.
