Summary Explanation/ Background:

THE CITY OF LAUDERHILL AND BROWARD COUNTY ENTERED INTO THE ORIGINAL 2016-2017 AGREEMENT FOR THE PURPOSE OF PURCHASE ASSISTANCE ON MAY 24, 2016. THE CITY OF LAUDERHILL REQUESTED AN EXTENSION TO COMPLETE THE LAST PROJECT AND SUBMIT FINAL CLOSEOUT REPORT TO THE COUNTY. THIS EXTENSION WILL ALLOW FUNDING TO REMAIN ACTIVE UNTIL SEPTEMBER 30, 2020.
