Request Action:

Request the approval of the renewal submitted by Humana Group Dental Insurance to include

HMO and PPO coverage plans. This agreement covers the contract two-year period October 1, 2021 through September 30, 2023.

To provide dental insurance benefits to eligible employees.

Humana has agreed to continue the current rates for the DHMO and DPPO plans for a period of two years ending September 30, 2023.
