

RESOLUTION NO. 19R-09-207

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; AUTHORIZING THE PURCHASE OF TWO (2) WACKER NEUSON HEAVY DUTY MOBILE GENERATORS FROM KELLY TRACTOR BASED UPON THE PIGGY BACK OF THE FLORIDA ASSOCIATION CONTRACT (FSA 18-VEH16.0); PROVIDING FOR PAYMENT IN THE TOTAL AMOUNT NOT TO EXCEED \$127,980.00 FROM VARIOUS BUDGET CODE NUMBERS INDICATED; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the Florida Association has already solicited bids (FSA 18-VEH16.0) and awarded a contract to Kelly Tractor for the purchase of various necessary vehicles; and

WHEREAS, the City of Lauderhill wishes to award the contract to Kelly Tractor based upon the bids by the Florida Association to purchase two (2) Wacker Neuson Heavy Duty Mobile Generators; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract to Kelly Tractor for the purchase of two (2) Wacker Neuson Heavy Duty Mobile Generators based upon the bids solicited by the Florida Association (FSA 18-Veh16.0), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment in an amount not to exceed \$127,980.00 shall be made from Budget Code Numbers 401-917-6440, 401-921-6440, and 401-933-6440.

Section 4. This Resolution shall take effect immediately upon its passage.
