

**RESOLUTION NO. 24R-09-215**

**A RESOLUTION RESCINDING AND REPLACING RESOLUTION NO. 24R-07-132 APPROVING THE REVISED SECOND AMENDMENT TO THE SOLID WASTE COLLECTION AND HAULING SERVICES AGREEMENT AND THE AMENDMENT TO THE RECYCLING COLLECTION SERVICES FRANCHISE AGREEMENTS BETWEEN THE CITY OF LAUDERHILL AND WASTE MANAGEMENT INC. OF FLORIDA TO INSTEAD EXTEND BOTH FRANCHISE AGREEMENTS FOR A TERM OF TWELVE (12) MONTHS TO ENABLE THE REQUEST FOR PROPOSAL (RFP) PROCESS TO BE COMPLETED AND TO PROVIDE THE SELECTED SERVICE HAULER TIME TO MOBILIZE AND BE PREPARED TO PROVIDE SERVICES; PROVIDING RATES EFFECTIVE COMMENCING OCTOBER 1, 2024 FOR THE TWELVE MONTH PERIOD; AMENDING RATES TO PROVIDE WATER TREATMENT PLANT SLUDGE COLLECTION; PROVIDING THAT ALL OTHER TERMS AND CONDITIONS WILL REMAIN IN EFFECT UNTIL TERMINATED; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

**BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:**

SECTION 1. Resolution No. 24R-07-132 which approved a six (6) month extension is hereby rescinded and replaced.

SECTION 2. The Revised Second Amendment to the Solid Waste Collection and Hauling Services Agreement and the Amendment to the Recycling Collection Services Franchise Agreements between the City of Lauderhill and Waste Management Inc. of Florida to provide exclusive solid waste for all users citywide and exclusive residential recycling services citywide to extend the Franchise Agreements for an additional twelve (12) months through September 30, 2025 based upon the rates stated in the Exhibits thereto for the duration of the twelve (12) months, which rates include the collection of sludge from the Water Treatment Plant, a copy of which is attached hereto and incorporated herein, is hereby approved. If the agreement should need to be extended beyond the twelve (12) month period, there is an option to extend at the increased rates stated therein.

SECTION 3. The City Manager, her designee, and all appropriate city officials are authorized to execute this Agreement and any other documents required to fulfill the terms of this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
