## **RESOLUTION 19R-01-01**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL SETTING FORTH THE PROOF OF RESIDENCY REQUIREMENTS FOR CANDIDATES AS SET FORTH IN THE CHARTER SECTION 7.02; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA).

WHEREAS, on November 6, 2018, the residents voted in favor of a Charter Amendment to Section 7.02 imposing a 2-year minimum residency requirement for candidates; and

WHEREAS, the provision states that a Resolution shall be passed to provide the specific residency requirements;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION FOR THE CITY OF LAUDERHILL, THAT:

<u>Section 1</u>. That the proof of residency requirements for candidates for the City of Lauderhill mayor of city commissioner shall be as follows:

In order to qualify to become a candidate for mayor or for city commissioner, an individual must present proof to the City Clerk that he/she has been a permanent resident of the City of Lauderhill for a continuous twenty-four (24) month period prior to the date of the next scheduled election.

To meet this residency requirement, the individual must provide at least two (2) of the following forms of identification as indicated below:

- 1. A valid U.S. Government Issued driver's license or ID card *must* be provided which contains the individual's name and a valid Lauderhill address; in addition to any one (1) of the following additional documents; and:
- 2. In addition to Section (1) above, the individual must also produce one (1) of the following:
  - (a) a lease, rental receipt, deed, or mortgage statement, homeowner's or renter's insurance policy that contains the individual`s name and a valid Lauderhill residential address: or
  - (b) a property tax bill that contains the individual's name and a valid Lauderhill residential address; or
  - (c) a utility bill that contains the individual's name and a valid Lauderhill residential address; or

(d) a voter registration card showing the individual's name and a valid Lauderhill residential address.

All documents shall have an issue date **on or before** the first of the November two (2) years before the election candidate files to run for office.

 $\underline{\text{Section 2}}.$  This Resolution shall take effect immediately upon its passage and adoption.
