Commissioner Dunn remarked the \$2.1 million that was a part of a general obligation (GO) bond was substantial; she asked for clarity on the process to ensure small business enterprise (SBE) participation, as 25 percent of \$2.1 million was a great opportunity for local business participation.

Deputy City Manager/Finance Director Kennis Hobbs affirmed GO bond dollars were being utilized to fund the subject project; part of the request for proposal (RFP) information included the City's SBE Program requirement, so vendors were aware they must participate based on SBE guidelines established by the City of Lauderhill. He noted the City's Purchasing staff would work with the selected vendor to ensure the required percentage for local business participation was adhered to.

Commissioner Dunn asked staff, once the contract was finalized, to report to the Commission, as a group, on the final outcome of this particular contract; it would be good to know as a case study. She felt sure Mr. Hobbs's team was developing a process to identify potential subcontractors, and match them accordingly.

XVII COMMUNICATIONS FROM PUBLIC OFFICIALS SHALL BEGIN IMMEDIATELY BEFORE ADJOURNMENT

City Attorney Rosenberg announced, with elections coming up in August and November 2024, city staff observed various activities going on; one was a political sign posted on the Swap Shop property; such signs were not yet permitted to be posted. She gave a PowerPoint presentation as a quick synopsis of what should and should not happen:

- A \$200.00 nonrefundable cash bond was required prior to posting any political signs, paid at the City's cashier at City Hall; failure to post the cash bond would result in a \$50.00 per day fine
- The two elections were the primaries, and the general election
- There were different deadline dates when candidates were allowed to post signs relating to each election or issue; to post signs for a candidate or issue on the August 20th election ballot, the deadlines for posting political signs were as follows: in residential districts, signs could be posted 90 days prior to the election, which was May 22, 2024; for nonresidential/commercial districts, signs could be posted 60 days prior to the election, which was June 21, 2024; to post signs on private property, candidates or interested parties must obtain permission from the property owner
- For the November 5th General Election candidates or issues on that ballot the deadlines for posing signs were as follows: in residential districts, August 7, 2024; in nonresidential/commercial districts, September 6, 2024; again, candidates must get property owners' permission before posting any signs on private property
- No signs could be posted on City property, including parks, and rights of way
- No sign could be posted within ten feet of any City of Lauderhill permanent sign
- Improperly posted signs must be removed either by the candidate, the

property owner, or the City; if the City removed the sign, the cost of removal would be deducted from the cash bond posted

- On the map shown, everything highlighted in red was public/City property on which no signs could be posted; the City Clerk's Office had the map on file, so copies could be sent to anyone upon request accordingly
- All candidates should acquaint themselves with the Florida statutes, so they understood their rules for candidacy, as certain language was allowed, and not allowed on advertisements; for example, candidates could not say they were an incumbent if they were not, nor could they use the word reelect if they never served in the position
- There was a Code of Ethics for Candidates that the City provided to every candidate; it was a requirement that every candidate running for the City of Lauderhill City Commission must sign the City's Code of Ethics acknowledgement document, and return it to the City Clerk's Office; a number of candidates have yet to return their signed form to the City Clerk, which meant they were considered past due, as they should have been submitted by February 26, 2024, and upon opening a campaign account; candidates failing to submit the form risked being fined up to \$500.00 per violation per day
- Candidates were urged to remain diligent about the rules, as it was highly likely a candidate's opponent would file a complaint if they discovered this violation.

Vice Mayor L. Martin wondered if the City Clerk could identify candidates whose signed Code of Ethics forms had yet to be submitted to the City Clerk.

City Attorney Rosenberg responded the City Clerk had a list, and she believed the City Clerk sent emailed reminders; so it was not a secret.

Vice Mayor L. Martin asked that the information be made public at the next Commission meeting. He went on to provide the following update:

- Lauderhill Track Club had their end-of-the-year celebration; Commissioner Dunn and he helped pass out medals to the children
- 55+ Walking Program was at St. George Park; the program moved around to various participating city parks; they had people walking in excess of 300 miles over time; the City tracked participants' miles as they walked, then gave out gift cards to those who walked the furthest; he thought one of the walkers in St. George might be over 80 years old
- The St. George community was very active in exercising led by Omar, who worked with the residents to help keep them active
- He attended the Broward County Public Schools repurposing meeting held at Dillard High School; in a recent conversation, Broward Estates Elementary was said to be on the list of schools to be closed due mainly to low enrollment; the latest news he received from Broward County School Superintendent Dr. Howard Hepburn was those decisions were being pushed back; for now, nothing would be happening in the next school year, giving schools time to pay attention to what was happening, possibly finding ways to improve
- He was a co-host at the Mothers Against Gun Violence Symposium held at the Lauderhill Performing Arts Center (LPAC); there were four mothers, and one father in attendance whose children were victims of gun violence; the turnout was not as great as expected, but the effort was greatly appreciated by those who lost loved ones, giving them a chance to tell their stories, and share

- information; Tony Sands, another cohost, was a local athlete from St. Thomas
- He attended the Broward Education Gala Scholarship and Teachers support group; this was a group that gave out money to the community, and supported the City's children; Parkway Middle's students performed at the event, doing an awesome job; a gentleman in attendance ran a school supply store, where teachers could shop free of charge for school supplies for their classrooms; he was working with the gentleman to bring one of his outlets to Lauderhill
 - The World Cup Cricket trophy to be awarded to the 2024 winner was now at the cricket stadium; in a month and a half, the World Cup Cricket event would begin, and he anticipated a significantly large crowd; the venue just had new cricket stands installed, and the City could reap the benefit of those stands years after the cricket event
 - 2024 Relay for Life Cancer Walk took place at Carter Park the past weekend; he was proud to represent the City of Lauderhill; Lauderdale Lakes, and the City of Fort Lauderdale hosted this walk for a number of years; it was uplifting to see the cancer survivors who turned out, and a great way to celebrate being alive
 - The Haitian and Hilarious Comedy Show would take place at the LPAC on Thursday, May 16, 2024, at 8:00 p.m.; he urged everyone to support the event as part of the celebration of Haitian Heritage Month.

Commissioner Dunn noticed a political campaign sign posted in the City of Sunrise near University Drive and NW 44th Street at the 4400 building. She asked how staff was getting information the City Attorney just detailed regarding posting political campaign signs to those outside Lauderhill to ensure they, too, were aware of the City's policies.

City Attorney Rosenberg replied the regulations were a part of the City's code, but the city staff did not monitor every candidate; if a candidate was going to post a sign, it was their responsibility to contact the City to find out the regulations they had to abide by in addition to the State law. She recommended when a sign was observed to be improperly posted, the City should be informed, so staff could contact the candidate to let them know, and give them an opportunity to remove the sign, letting them know about the City's cash bond in order to post such signs in Lauderhill, rather than city staff discarding their sign. She went on to give her update as follows:

- Lauderhill Shines Graduation would take place on Wednesday, May 15, 2024, at St. George Park, at 6:00 p.m.; anyone wishing to celebrate the achievement of the entrepreneurs who completed the program was welcome, as well as the City's elected officials
- On Friday, May 17, 2024, the Leading Ladies Circle would be hosted at the City of Grace Church; the Leading Ladies Circle was chaired by Prophetess Monique Henry; any woman of faith in Lauderhill was welcome to join the Leading Ladies Circle, whose mission was to pray for the City of Lauderhill, and to advocate peace; they were taking a huge role in driving the Lauderhill Peace365 campaign forward; they fellowshiped with other women committed to making the City a safe, healthy, and prosperous community with a faith-based approach
- She was on the Board of Directors for the National Black Caucus of Local Elected Officials (LEO); their 2024 conference would take place June 25 through the 27, 2024, in Chicago; her fellow Commissioners would receive

notice of the event;

- She served on the Board of Women in Municipal Government; their conference would take place July 17 through 19, 2024; the national president was a commissioner in the City of Miramar, and, typically, this conference was hosted in the president's city of residence, but the current president would host the conference at the City of Hollywood Diplomat
- The Florida League of Cities (FLC) Conference would take place on August 15 through 17
- Lauderhill residents wishing to make Lauderhill a safer community should go to the City's website, and type in PEACE365 to take the peace pledge.

Commissioner S. Martin announced a Memorial Day Ceremony would be held on Memorial Day, Monday, May 27, 2024, at Lauderhill Veterans Park; he urged everyone to attend.

Commissioner Grant remarked it had been a very impactful two weeks that showed Lauderhill moving in the right direction, and there were numerous activities taking place. She commented oftentimes it was said being a local government official was a part time job, but it was not. She went on to highlight the following:

- On Saturday, May 18, 2024, a large function would be held at Winning Souls and Charitable Church in celebration of Haitian Flag Day
- FIFA and the United Nations (UN), Under Armour, and Pepsi were bringing a soccer clinic to the City of Lauderhill; FIFA contacted her, and the Parks Department would undertake that initiative; student athletes would do a clinic, as well as training for the coaches; she believed on August 18, 2024, there would be a major event in relation to the soccer clinic; members of Manchester United, and Manchester City, two major United Kingdom (UK) teams would be present, along with FIFA and the UN; they were doing a tour across the U.S., as the 2026 World Cup for soccer would take place in the U.S., so these entities and professional players were visiting Lauderhill as the first stop.

Mayor Thurston mentioned the following:

- Thursday, May 9, 2024, The Lauderhill PD was complimented for holding a great Police Memorial Program; they honored the memory of Sergeant Corey Pendergrass, the first Lauderhill officer to die of COVID 19, which he contracted while on duty
- Thursday, May 9, 2024, there was a Police Benevolent Association event, at which the Officer of the Year was designated for Broward County; the City's nominee was Officer Colon, who represented the City of Lauderhill well
- Friday, May 17, 2024, at 6:00 p.m. was the Teacher of the Year Appreciation Dinner; it was a free event, but anyone wishing to attend needed to make a reservation by giving his aide a call at 954-777-2040. He noted Lauderhill schools already selected their Teacher of the Year, and they would be honored for the great work they continued to do for the City's children.
