HB 657 / FSS 316.1896

- Allows use of Camera system to enforce School Zone Speed limits.
 - 30 min before/after schools starts
 - · Includes a breakfast program
 - 30 min before/after school releases
 - During the school day
- Offenders going more than 10mph over the limit
 - All School zones in Lauderhill are 15mph
 - 26 mph wins a \$100 penalty
- 30 Day Education & Warning Campaign

PROCESSING

System captures a violation and sends it to the vendor.

Vendor reviews violation and sends it to PD

• PD Traffic Enforcement Specialist validates the violation

Vendor mails notice of violation to owner

OWNER HAS 4 OPTIONS

- Pay Violation
 - \$20 State (General Revenue Fund)
 - \$3 CJST Trust Fund
 - \$12 Broward County Schools
 - \$5 Crossing Guard Fund
 - \$60 Agency/Vendor
- Request a Hearing
 - Similar to a Code violation Hearing
- Not Me Affidavit
 - Must provide info on who was driving
 - If that person also claims not me goes back to owner.
- Ignore
 - Issued a UTC by the Vendor

CITY RESPONSIBILITIES

- FSS Requires an ordinance to establish a program
- Vendor Selection
- Identify Locations of a "Heightened Safety Risk"
- Provide a Traffic Infraction Enforcement Officer
- Hold hearings as requested
- Create Crossing Guard Recruitment and Retention Fund
- Collect and disperse funds
- Annual Report
