A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL PROVIDING PUBLIC NOTICE OF AND APPROVING AND ACCEPTING THE MODIFIED FUNDING AMOUNT FOR THE 2019 EDWARD BYRNE JUSTICE ASSISTANCE LOCAL SOLICITATION GRANT (JAG) MEMORANDUM OF UNDERSTANDING (MOU) IN THE NET AMOUNT OF \$41,002.20 AFTER ADMINISTRATIVE FEES; APPROVING EXECUTION OF THE SUB-RECIPIENT AGREEMENT AND OTHER NECESSARY DOCUMENTATION; PROVIDING THAT NO MATCHING FUNDS ARE REQUIRED; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, The City of Lauderhill previously passed Resolution No. 19R-08-159 approving and accepting the 2019 JAG Grant MOU in the original amount of \$42,991.20 net funds to be received; and

WHEREAS, the City has been advised by the Department of Justice that the funding amount for the 2019 JAG Grant MOU is being adjusted to the net amount of \$41,002.20;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The City of Lauderhill hereby provides public notice of, approves and accepts the 2019 Edward Byrne Justice Assistance Local Solicitation Grant (JAG) Memorandum of Understanding (MOU) in the modified net amount of \$41,002.20, after administrative fees, a copy of which is attached hereto and incorporated herein.

Section 2. The City of Lauderhill hereby approves the Subrecipient Agreement to be entered into with the City of Pompano Beach, to serve as Lead Agency for this Grant, a copy of which is attached hereto and incorporated herein.

Section 3. The City of Lauderhill hereby authorizes the appropriation of funds to the individual revenue and expenditure accounts.

Section 4. The City Manager, and all appropriate City officials including the Police Chief, are authorized to execute the 2019 JAG Memorandum of Agreement (MOU), the Subrecipient Agreement, as well as any other documents necessary to fulfill the terms of this Resolution. Any documents that may have required earlier execution to meet necessary time deadlines are approved retroactively.

Section 4. This Resolution shall take effect immediately upon its passage.
