

**RESOLUTION NO. 19R-10-231**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; AUTHORIZING THE PURCHASE OF OFFICE SUPPLIES FROM OFFICE DEPOT, INC., ON AN AS NEEDED BASIS, BASED UPON THE SOUTHEAST FLORIDA GOVERNMENTAL COOPERATIVE GROUP AND THE BIDS SOLICITED BY THE CITY OF TAMARAC ACTING AS LEAD AGENCY (BID 19-12R); PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)**

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Tamarac has already solicited bids (Bid 19-12R) and awarded a contract to utilize Office Depot, Inc. for the purchase of office supplies; and

WHEREAS, the City of Lauderhill wishes to award the contract based upon the bids solicited by the City of Tamarac for office supplies; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract for the purchase of office supplies from Office Depot, Inc., based upon Southeast Florida Governmental Cooperative Group and the bids solicited by the City of Tamarac acting as Lead Agency (Bid 19-12R), a copy of which is attached hereto and incorporated by reference.

Section 3. Providing that payment shall be made on an as needed basis from the appropriate Budget Code Number(s).

Section 4. This Resolution shall take effect immediately upon its passage.
