A RESOLUTION OF THE CITY COMMISSION OF THE CITY **OF** LAUDERHILL. **FLORIDA** APPROVING MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE SCHOOL BOARD OF BROWARD COUNTY AND THE CITY OF LAUDERHILL TO COLLABORATIVELY SUPPORT AND PROMOTE SAVE PROMISE CLUBS TO HELP PREVENT VIOLENCE WITHIN SCHOOLS AND THE BROADER COMMUNITY IN CONJUNCTION WITH THE LAUDERHILL PEACE 365 INITIATIVE IN SUBSTANTIALLY THE SAME **FORM ATTACHED HERETO** AS **EXHIBIT** "A": AUTHORIZING THE INTERIM CITY MANAGER TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION: AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY COMMISSIONER MELISSA P. DUNN).

WHEREAS the Lauderhill Peace 365 Initiative was created to foster peace and harmony in Lauderhill especially among the youth; and

WHEREAS the City of Lauderhill and the Broward County School Board are seeking to work together via the proposed Memorandum of Understanding (MOU) to establish SAVE Promise Clubs to foster and enhance student-led initiatives that encourage positive behavior and violence prevention through the Lauderhill Peace/Save Promise Clubs; and

WHEREAS, the Lauderhill Peace 365 Initiative has played a role in making Lauderhill safer, healthier, and more prosperous; and

WHEREAS the City Commission of Lauderhill believes it is in the best interest of the City to approve the proposed MOU between the City of Lauderhill and the Broward County School Board.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

<u>Section 1.</u> The City Commission of the City of Lauderhill hereby approves the proposed Memorandum of Understanding (MOU) between the School Board of Broward County and the City of Lauderhill to work collaboratively to support and promote Save Promise Clubs to help prevent violence within the schools and broader community in conjunction with the Lauderhill Peace 365 (Peace 365), attached as Exhibit "A" in substantially the same form.

<u>Section 2.</u> The City Commission of the City of Lauderhill hereby authorizes the Interim City Manager to execute all documents necessary to fulfil the terms of this Resolution.

<u>Section 3.</u> This Resolution shall take effect immediately upon its passage.
