Request Action:

Approve the City Manager to execute the Public Emergency Medical Transportation (PEMT) with the State of FLorida.

Need Summary Explanation/ Background:

State Fiscal Year 2025-2026, the City of Lauderhill shall remit to AHCA an amount not to exceed Seven Hundred Seventy-Seven Thousand Six Hundred Ninety-Six Dollars and Twenty-Six Cents (\$777,696.26), which is established annually by AHCA based on Lauderhill Fire Rescue’s reported Medicaid transport costs and utilization.
