

**RESOLUTION NO. 26R-06-97**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING CHANGE ORDER NUMBER 2 WITH DI POMPEO CONSTRUCTION CO., IN THE AMOUNT OF \$88,053.00, FOR ADDITIONAL SERVICES TO REMOVE SILT MATERIAL TO STABILIZE SOIL CONDITIONS, ETC., PURSUANT TO RFP NUMBER 2023-027; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 307-19355-506212; PROVIDING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS JR.).**

WHEREAS, the City of Lauderhill awarded RFP #2023-027, a Police Substation Project and entered into an agreement with Di Pompeo Construction Corporation (Di Pompeo) for construction services; and

WHEREAS, the City approved change order number 1 because additional work was needed to stabilize and improve soil at the site before construction could begin; and

WHEREAS, City staff recommends approving change order number 2 because additional silt material needs to be removed to stabilize the soil conditions based on the geotechnical report recommendation, among other things; and

WHEREAS, Di Pompeo has submitted change order, number 2, attached hereto, in the amount of \$88,053.00 to perform the work; and

WHEREAS, City staff has reviewed the change order and recommends approving same.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitations are true and hereby incorporated herein.

SECTION 2. Change Order Number 2 with Di Pompeo, in an amount not to exceed \$88,053.00, is hereby approved.

SECTION 3. Payment shall be made from budget code number 307-19355-506212.

SECTION 4. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 5. This Resolution shall take effect immediately upon its passage.
