There is currently a nationwide class action against PVCP Pipe manufacturers for price fixing in the case styled In re PVC Pipe Antitrust Litigation, 24-cv-07639 (N.D. Ill) ("PVC Pipe Class Action"), and local governments like the City of Lauderhill may have been subject to the price fixing scheme for years. The City may be entitled to compensation .
