

**RESOLUTION NO. 25R-09-190**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, AMENDING RESOLUTION NO. 25R-08-157 RENAMING NORTHWEST 42<sup>ND</sup> WAY AS "CHARLES BOOTHE, SR. WAY" IN HONOR OF THE MEMORY OF CHARLES E. BOOTH, SR. AND FOR HIS CONTRIBUTIONS AND SERVICES TO THE LAUDERHILL COMMUNITY; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY COMMISSIONER JOHN T HODGSON).**

WHEREAS, in 2003, the City Commission enacted Resolution No. 03R-03-50 to outline the requirements for renaming City Streets; and

WHEREAS, Charles E. Boothe, Sr. was a businessman and philanthropist. Charlie, as he was popularly known, owned and operated "Charlies Bakery" in the Lauderhill Mall since 1986. He died on February 6, 2008; and

WHEREAS, Charlie's Bakery, which still operates today, has employed approximately 190 individuals, most of whom are residents of Lauderhill. The business has participated in many community events such as the former Kids Day at Wolk Park and most recently, has recently donated food items to the Central Park Library for its Caribbean Heritage Festival. Mr. Boothe also made regular contributions to Lauderhill STEM K-12, Paul Turner Elementary, and Castle Hill Elementary for school events and Teacher Appreciation Week; and

WHEREAS, Charles E. Boothe, Sr. who has been a stalwart in the Lauderhill community, is remembered as a man who left his mark in the history of the City of Lauderhill; and

WHEREAS, by Resolution No. 25R-08-157, adopted on August 25, 2025, the City Commission renamed Northwest 42<sup>nd</sup> Way as "Charles Boothe Way"; however, the senior designation is required for Charles Boothe's name; and

WHEREAS, the City of Lauderhill now wishes to amend Resolution No. 25R-08-157 to rename Northwest 42<sup>nd</sup> Way as "Charles Boothe, Sr. Way", in memory of Charles E. Boothe, Sr.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:**

SECTION 1. In honor of the memory of Charles E. Booth, Sr. and for his contributions and services to the Lauderhill Community, Northwest 42nd Way is hereby renamed as "Charles Boothe, Sr. Way ", and Resolution No. 25R-08-157 is hereby amended.

SECTION 2. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
