Need Summary Explanation/ Background:

To approve the 2024 Edward Byrne Justice Assistance Local Solicitation Grant from the U.S. Department of Justice.

This Resolution is to approve and accept the 2024 Edward Byrne Justice Assistance Local Solicitation Grant (JAG) from the U.S. Department of Justice; which provides for the 2024 JAG Grant Award in an amount not to exceed \$47,999 (less administrative fees resulting in an award of up to \$42,749.10) that will be available to purchase a Ballistic testing trailer to facilitate in house testing of recovered firearms and prevent delays in investigations, facilitate prosecuting criminals and provide justice to victims of crimes. There is no match requirement.
