MEMORANDUM OF UNDERSTANDING BETWEEN

THE SCHOOL BOARD OF BROWARD COUNTY, FLORIDA

AND

THE CITY OF LAUDERHILL

This Memorandum of Understanding (MOU) OUTLINES THE AGREEMENT BETWEEN THE School Board of Broward County (hereinafter referred to as "the District") and the City of Lauderhill (hereinafter referred to as "the City") to collaboratively support and promote SAVE Promise Clubs to help prevent violence within schools and the broader community in conjunction with the Lauderhill Peace 365 Initiative (hereinafter referred to as "Lauderhill Peace 365"). The Lauderhill Peace 365 Initiative is a commitment to make peace personal, every day, creating a safer and more peaceful Lauderhill together. SAVE Promise Clubs are student-led, prosocial clubs that aim to empower young leaders to take an active role in increasing school safety and preventing different forms of violence in schools and communities.

I. Objectives

- 1. **Promote Prosocial Behavior:** To foster and enhance student-led initiatives that encourage positive behavior and violence prevention through the Lauderhill Peace 365/SAVE Promise Clubs.
- 2. Provide Support and Resources: To ensure Lauderhill 365/SAVE Promise Clubs are well-supported through access to facilities, funding, and other resources provided by the City.

II. Responsibilities of the District

- 1. Establishment of SAVE Promise Clubs: Assist schools with the establishment of SAVE Promise Clubs.
- 2. Training and Development: organize and provide training to school-based club leaders (Champions) and community stakeholders on research-based violence prevention curriculum.
- **3. Funding Support:** Assist with locating resources to provide financial support for fieldtrips, activities, and other expenses related to Lauderhill Peace 365/SAVE Promise Clubs, including student sponsorships to

- national violence prevention leadership conference. District shall provide funding for the cost of the club advisor.
- **4. Club Management:** Provide monthly one-on-one support including club formation, expectations, deliverables, and sustainability.
- **5. Reporting and Evaluation:** Provide quarterly reports to the City on club progress, outcomes and impacts of the SAVE Promise clubs.

III. Responsibilities of the City:

- 1. **Training and Development:** organize and provide training to Lauderhill school leaders and community stakeholders on research-based violence prevention initiatives/programs.
- 2. Facility Provision: Offer access to suitable facilities for Lauderhill Peace 365/SAVE Promise Club training sessions and district/regional summits and events.
- 3. Funding Support: Assist in locating resources to provide financial support for field trips, activities, and other expenses related to Lauderhill Peace 365/SAVE Promise Clubs, including student sponsorships to national violence prevention leadership conference.
- **4. Resource Assistance:** Assist in the coordination of additional resources and support as required to ensure success of the Lauderhill Peace 365/SAVE Promise Club implementation.
- **5. Community Engagement:** Promote and support the Lauderhill Peace 365/SAVE Promise Clubs within the City's community outreach efforts and programs.

IV. Joint Responsibilities:

- **1. Collaboration:** Work collaboratively to organize and implement events and workshops that further the objectives of the Lauderhill Peace 365/SAVE Promise Clubs.
- **2. Evaluation:** Jointly evaluate the effectiveness and impact and make necessary adjustments to enhance their effectiveness.
- **3. Communication:** Maintain open and effective communication between the District and the City to ensure smooth coordination and address any issues that may arise.

V. Review:

1. **Review:** This MOU will be evaluated annually to determine if there are any needed changes. This MOU will remain valid unless either party determines a need to amend or terminate. Either party has the right to terminate this MOU for convenience with thirty (30) days notice.

VII. Signatures:

By signing below, the representatives of the District and the City of Lauderhill agree to the terms outlined in this Memorandum of Understanding.
