

**RESOLUTION NO. 26R-02-53**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING THE AWARD FOR REQUEST FOR PROPOSAL NUMBER 2026-014 – TRAVEL SOCCER PROGRAM TO COERFONTAINE FC LLC FOR THE OPERATION AND MANAGEMENT OF THE YOUTH TRAVEL SOCCER PROGRAM; PROVIDING FOR AUTHORIZATION TO NEGOTIATE FINAL CONTRACT TERMS; AUTHORIZING THE CITY MANAGER TO PROCEED TO THE NEXT HIGHEST RANKED PROPOSER IF NEGOTIATIONS ARE UNSUCCESSFUL; AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO EFFECTUATE THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).**

WHEREAS, the City issued RFP No. 2026-014 – Youth Travel Soccer Program (RFP) seeking qualified organizations to operate and manage the City’s Youth Travel Soccer Program; and

WHEREAS, there were four responses to the RFP which were reviewed, evaluated, and ranked by the evaluation committee; and

WHEREAS, the City Manager recommends the City Commission awards the RFP to Coerfontaine FC LLC, and authorizes the negotiation of an agreement with Coerfontaine FC LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, THAT:

SECTION 1. The above recitals are true and incorporated herein.

SECTION 2. Upon the recommendation of the City Manager the City Commission hereby awards Request for Proposals No. 2026-014 – Travel Soccer Program to Coerfontaine FC LLC.

SECTION 3. The City Manager is authorized to negotiate an agreement with Coerfontaine FC LLC, for the operation and management of the Youth Travel Soccer Program, in accordance with RFP specifications and contractual requirements.

SECTION 4. In the event negotiations with Coerfontaine FC LLC, are unsuccessful, the City Manager is authorized to terminate negotiations and proceed to negotiate and execute an agreement with the next highest ranked proposer, Futbol for Kids Foundation.

SECTION 5. The City Manager and City Attorney are authorized to do all things necessary to effectuate this Resolution.

SECTION 6. This Resolution shall take effect immediately upon its passage.
