

RESOLUTION NO. 23R-05-119

A RESOLUTION OF THE CITY OF LAUDERHILL CITY COMMISSION APPROVING THE WAIVER OF COMPETITIVE BIDDING; APPROVING THE PIGGYBACK OF THE BENNETT FIRE PRODUCTS COMPANY, INC. CONTRACT BASED UPON THE SOLICITATION BY LAKE COUNTY (CONTRACT #22-730B) FOR THE PURCHASE OF BUNKER GEAR FOR USE BY THE FIRE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$200,000.00; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBER(S) UTILIZING CDBG FUNDING; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, Lake County previously solicited bids and awarded a contract (Contract #22-730B) to Bennett Fire Products Company, Inc. for the purchase of bunker gear; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. That the purchase of bunker gear from Bennett Fire Products Company, Inc. to be used by the Fire Department, based upon the Bids solicited by Lake County (Contract #22-730B), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment shall be made from the appropriate Budget Code Number in an amount not to exceed \$200,000.00 utilizing CDBG funding.

Section 4. This Resolution shall take effect immediately upon its passage.
