

RESOLUTION NO. 19R-10-235

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL WAIVING COMPETITIVE BIDDING REQUIREMENTS; AUTHORIZING THE AWARD OF THE CONTRACT TO CITY FIRE, INC. TO PROVIDE FIRE EXTINGUISHER SERVICES INCLUDING TESTING, INSPECTION, MAINTENANCE, PARTS AND TOOLS, ON AN AS NEEDED BASIS, FOR THE REMAINDER OF THE TERM EXPIRING AUGUST 31, 2022 BASED UPON THE SOUTHEAST FLORIDA GOVERNMENTAL COOPERATIVE GROUP AND THE BIDS SOLICITED BY THE CITY OF HOLLYWOOD ACTING AS LEAD AGENCY (BID #F-4507-16-RD); PROVIDING FOR PAYMENT IN THE TOTAL AMOUNT NOT TO EXCEED \$20,000.00 FROM BUDGET CODE NUMBER 001-313-4615; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, CHARLES FARANDA)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the City of Hollywood has already solicited bids (Bid #F-4507-16-RD) and awarded a contract to City fire, Inc. for the contract for fire extinguisher services; and

WHEREAS, the City of Lauderhill wishes to award the contract based upon the bids solicited by the City of Hollywood for the purchase of fire extinguisher services; and

WHEREAS, the City Commission has determined that the award of this contract as set forth herein would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of the contract for fire extinguisher services including testing, inspection, maintenance, parts and tools, on an as needed basis, for the remainder of the term of the Agreement expiring August 31, 2022, based upon Southeast Florida Governmental Cooperative Group and the bids solicited by the City of Hollywood acting as Lead Agency (BID #F-4507-16-RD), a copy of which is attached hereto and incorporated by reference, is hereby approved.

Section 3. Providing that payment shall be made on an as needed basis in a total amount not to exceed \$20,000.00 from Budget Code Number 001-313-4615.

Section 4. This Resolution shall take effect immediately upon its passage.
