

**RESOLUTION NO. 25R-09-195**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, RENEWING A CONTRACT WITH DAVIES CLAIMS SOLUTIONS, LLC, TO PROVIDE THIRD PARTY ADMINISTRATION (TPA) SERVICES FOR WORKERS' COMPENSATION, LIABILITY, AUTOMOBILE, AND PROPERTY CLAIMS FOR THE CITY OF LAUDERHILL FOR THE COVERAGE PERIOD BEGINNING OCTOBER 1, 2025 AND ENDING SEPTEMBER 30, 2026, IN THE ESTIMATED AMOUNT OF \$55,389; PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).**

WHEREAS, Davies Claims Solutions, LLC, provides third party administration services for workers' compensation claims, as well as liability/automobile/property claims for the City of Lauderhill; and

WHEREAS, City staff recommends renewing its contract with Davies Claims Solutions, LLC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1: That the City Commission hereby approves renewal of the contract with Davies Claims Solutions, LLC, to provide Third Party Administration (TPA) of the City of Lauderhill's workers' compensation claims, as well as, liability/automobile/property claims for the City of Lauderhill for a one (1) year term beginning October 1, 2025 and ending September 30, 2026, a copy of which is attached hereto and incorporated herein.

SECTION 2: The City Commission also authorizes Davies Claims Solutions, LLC, to be responsible for the Section 111 Medicare, Medicaid and SCHIP Extension Act of 2007 ("MMSEA") reporting requirements mandated by the Center for Medicare and Medicaid Services as required to allow coordination of benefits with Medicare/Medicaid beneficiaries who receive settlements, judgments, awards or other payment from liability insurance or workers' compensation.

SECTION 3: That payment in the estimated amount of \$55,389 is hereby approved on an as needed basis from Budget Codes 001-01-162-50-4521, 001-01-162-50-4522, and 001-01-162-50-4523.

SECTION 4: This Resolution shall take effect immediately upon its passage and approval.
