

RESOLUTION NO. 21R-03-59

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL ESTABLISHING THE CITY OF LAUDERHILL HEALTH AND PROSPERITY PARTNERSHIP ("LHPP"); PROVIDING THAT THE LHPP WILL ENDEAVOR TO IMPROVE THE HEALTH, WELLNESS AND ECONOMIC PROSPERITY OF ALL RESIDENTS OF THE CITY OF LAUDERHILL; PROVIDING THAT THE LHPP WILL INCLUDE THE PARTICIPATION OF PUBLIC OFFICIALS, RESIDENTS, STAKEHOLDERS AND EXPERTS TO HELP DEFINE AND REFINE THE FUTURE HEALTH AND PROSPERITY OF THE CITY OF LAUDERHILL; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY COMMISSIONER MELISSA P. DUNN)

WHEREAS, the City of Lauderhill provides a full range of traditional municipal services to support its residents, such as public safety, public works, planning and zoning, engineering, parks and recreation and economic development; and

WHEREAS, in addition to the traditional municipal services, the City of Lauderhill is committed to providing a high quality of life for its residents, including quality health, wellness and economic prosperity; and

WHEREAS, the LHPP shall be dedicated to identifying the causes, the solutions and to develop a dynamic plan to improve the health, wellness and economic wellbeing of City of Lauderhill residents; and

WHEREAS, the mission of LHPP is to improve the quality of life for all Lauderhill residents by making the community a great place to live, learn, work, shop, play and worship; and

WHEREAS, the LHPP will utilize a collaborative impact model and place-based framework to address the social determinants of health (SDOH) which includes healthcare, education, economic stability, social and community context and built environment; and

WHEREAS, the LHPP will design policy, environmental and systems interventions to transform Lauderhill into a healthier and more prosperous community; and

WHEREAS, the LHPP will establish committees comprised of elected officials, residents, stakeholders and experts to define and refine the future health and prosperity of the City of Lauderhill;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA;

SECTION 1. The City Commission of the City of Lauderhill hereby establishes the Lauderhill Health and Prosperity Partnership, commonly known as the "LHPP".

SECTION 2. That the Lauderhill Health and Prosperity Partnership shall be dedicated to identifying the causes, the solutions, and to develop a dynamic plan to improve the health, wellness and economic wellbeing of City of Lauderhill residents.

SECTION 3. That the Lauderhill Health and Prosperity Partnership shall establish committees comprised of public officials, residents, stakeholders and experts to define and refine the future health and prosperity of the City of Lauderhill.

SECTION 4. This Resolution shall take effect immediately upon its passage.
