

Mr. Franceski retired from Federal Civil Service in 1999. In his last position he was the United States Atlantic Fleet Deputy Comptroller, overseeing a staff of 100 military and civilian personnel and an operating budget in excess of five billion dollars. He had 34 years experience in Navy financial management, supporting all facets of Navy operations, including logistics, aviation, surface warfighting, and overall Fleet operations. He also served in the Navy during the Vietnam War.

He started his civil service career in 1965 at Norfolk Naval Supply Center where he was responsible for financial planning and budgeting for the world's largest Navy logistics distribution point and Military Ocean Terminal. The Supply Center and Ocean Terminal provided logistics support to U.S. Naval forces in the Atlantic and Mediterranean, and all contiguous waters and land masses. In 1980 he became responsible for financial planning, budgeting, and information technology for Norfolk Naval Air Station. The Air Station supported nearly 100 Naval Aviation operating, maintenance, and overhaul commands. In 1989 he became responsible for warfighting requirements determination, program planning, and budgeting for the Atlantic Fleet Surface Force. This Force was comprised of nearly 300 operational and support commands with 150,000 personnel conducting operations from the Great Lakes and East and Gulf Coasts to South America, the Atlantic and Mediterranean, Persian Gulf and contiguous waters and land masses. Beginning in 1994, as Atlantic Fleet Deputy Comptroller, he was responsible for the Claimant Program Objective Memorandum, operating budget, accounting policy and procedures, and budget development and execution systems for the Atlantic Fleet. The Atlantic Fleet was the Force Provider for Surface, Naval Air, and Submarine Forces as required by the Warfighting Commanders-in-Chief and the Strategic and Special Operations Commands.

After retiring he provided business consulting services in Activity Based Costing/ Activity Based Management to a large Defense contractor, including support for Great Britain's Royal Navy.

Mr. Franceski has a Bachelor of Science Degree in Economics and Statistics from the University of Scranton (1965) and a Master of Business Administration from Old Dominion University (1972); has completed Executive Development programs at Kellogg School of Management at Northwestern University and Professional Military Comptroller School at USAF Air University; along with numerous professional/technical courses from the U.S. Office of Personnel Management.

He is a Life Member of the American Society of Military Comptrollers; a Certified Government Financial Manager in the Association of Government Accountants; and a Certified Business Manager in the Association of Professionals in Business Management. He was an accomplished Toastmaster in Toastmasters International. He was very active in the Combined Federal Campaign and the United Way of South Hampton Roads in Virginia. He was the chairman of his church Finance Council and the Finance Council of the Catholic Diocese of Richmond, VA. He served on the Virginia Beach Mayor's Special Advisory Commission on Electronic Government. He has been the Vice President of the Board of Directors of The Hills of Inverrary Condominium Association in Lauderhill, FL. for more than five years. In this capacity he has completed various courses in continuing education to maintain proficiency in Florida Statute 718, Condominiums. He has served on the Lauderhill Housing Authority Board of Commissioners for four years, the last three as Chair.

He lives in Lauderhill with his wife, Jan. They have two daughters, seven grandchildren and one great-grandchild.
