## **RESOLUTION NO. 25R-09-162**

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING A CHANGE ORDER IN AN AMOUNT NOT TO EXCEED \$38,300.00 FOR ADDITIONAL WORK ON THE SADKIN COMMUNITY CENTER ELEVATOR TO COMPLETE MODERNIZATION OF THE PROJECT; PROVIDING FOR PAYMENT FROM BUDGET CODE NUMBER 307-19326-506534; AND PROVIDING FOR AN EFFECTIVE DATE. (REQUESTED BY CITY MANAGER KENNIE HOBBS, JR.).

**WHEREAS** by Resolution No. 24R-11-274, the City of Lauderhill ("City") entered into a contract with Oracle Elevator Company ("Oracle") in the amount of \$87,433.00 to renovate the Sadkin Community Center Elevator; and

**WHEREAS** by Resolution No. 25R-03-48 an additional \$50,440.00 was approved to complete the renovation and bring the elevator mechanical machine room and fire alarm system up to the Code; and

**WHEREAS** Oracle requires an additional \$38,300.00 to install a new hydraulic cylinder; and

**WHEREAS**, the additional funds will allow Oracle to complete the work for the renovation of the Sadkin Community Center Elevator Project; and

**WHEREAS,** the Mayor and City Commission of the City of Lauderhill find it is in the best interests of the City to authorize the City Manager or designed to approve the Change Order for Oracle in the amount of \$38,300.00.

SECTION 1. The above recitations are true and hereby incorporated herein.
