

**RESOLUTION NO. 21R-08-174**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL APPROVING THE SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT BETWEEN BROWARD COUNTY AND THE CITY OF LAUDERHILL FOR COMMUNITY BUS SHUTTLE SERVICES TO AMEND EXHIBIT "D" LISTING THE VEHICLES THAT ARE BEING UTILIZED FOR THE CITY`S AGREEMENT WITH ITS SUBCONTRACTOR; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, DESORAE GILES-SMITH)**

WHEREAS, Broward County previously advised that it will fund all community bus shuttle service routes utilizing 100% of funding from Transportation Sales Tax Funds; and

WHEREAS, Resolution No. 19R-09-200 previously approved the Interlocal Agreement with Broward County which includes all the terms and conditions; and

WHEREAS, the third party contractor, South Florida Limousines, advised of the modified rate of \$45.00 per hours; and

WHEREAS, Resolution No. 20R-10-221 approved the First Amendment to the Interlocal Agreement which reflected the actual modified rate to be charged by the operator as the rate for reimbursement to the City of Lauderhill; and

WHEREAS, this Resolution approves the Second Amendment to the Interlocal Agreement to amend Exhibit "D" to reflect the vehicles that are being utilized for the City`s Agreement with its subcontractor;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

SECTION 1. The Second Amendment to the Interlocal Agreement between the City of Lauderhill and Broward County to amend Exhibit "D" to reflect the list of vehicles being utilized for the City`s Agreement with its subcontractor, a copy which is attached hereto and incorporated by reference, are hereby approved.

SECTION 2. The City Manager and all appropriate city officials are authorized to execute this Agreement and any other documents required to fulfill the terms of this Resolution.

SECTION 3. This Resolution shall take effect immediately upon its passage.
