Request to approve the piggybacking on the Florida Sheriff Contract Vendor bid #FSA22-VEL30.0 for the purchase of seven (7) vehicles to be used by the Police Department from BOZARD FORD or any other Florida Sheriff's Contract vendor not to exceed \$380,625.00.
