**Request Action:**

Pass an Ordinance to modify the list of projects funded by the City's General Obligation Bonds, Series 2017 and Series 2018 within the Park, Recreational, Leisure and Cultural Projects.

**Need Summary Explanation/ Background:**

There remains a balance in some of the funds in some of the projects and it is the desire for the city to transfer those balances for use for other eligible projects within the same categories. This modification is to delineate the change to the specific projects for the funding to be spent on. The modification includes the following transfers:

1. From St. George Park (funded by Series 2018 GO Bonds) \$782,986.94 and from Bradley Park (funded by Series 2018 GO Bonds) \$10,464.06 to transfer the total of \$793,451.00 to Maye Jenkins Park.
2. From Renaissance Park (funded by Series 2017 GO Bonds) \$96,600.00 and South Gateway Park (funded by Series 2017 GO Bonds) \$3,400.00 to transfer the total of \$100,000.00 to Windermere Park Community Center Roof.
