

RESOLUTION NO. 20R-10-219

A RESOLUTION APPROVING THE WAIVER OF COMPETITIVE BIDDING; APPROVING THE AWARD OF CONTRACT TO CLOUD SOLUTIONS TO ALLOW FOR THE PURCHASE OF PRODUCTS AND SERVICES AS NEEDED FOR THE CITY'S INFORMATION SYSTEMS INFRASTRUCTURE IN AN AMOUNT NOT TO EXCEED \$300,000.00 BASED UPON THE BIDS SOLICITED BY THE STATE OF FLORIDA DEPARTMENT OF MANAGEMENT SERVICES (432300000-NASPO-16-ACS); PROVIDING FOR PAYMENT FROM THE APPROPRIATE BUDGET CODE NUMBERS ON AN AS NEEDED BASIS; PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY INTERIM CITY MANAGER, DESORAE GILES-SMITH)

WHEREAS, Section 2-144 of the Code provides that the City of Lauderhill may join in on cooperative purchasing plans without bids when the best interests of the City would be served; and

WHEREAS, the State of Florida Department of Management Services (432300000-NASPO-16-ACS) solicited bids to allow for the purchase of products and services as needed for Information System Infrastructure; and

WHEREAS, the City of Lauderhill has reviewed the bids solicited by the State of Florida and wishes to award the contract to Cloud Solutions to allow for the purchase of products and services as needed for the City's Information Systems Infrastructure; and

WHEREAS, the City Commission has determined that this purchase would serve the best interests of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

Section 1. The waiver of competitive bidding is hereby approved.

Section 2. The award of contract to Cloud Solutions to allow for the purchase of products and services on an as needed basis for the City's Information Systems Infrastructure, in an amount not to exceed \$300,000.00, based upon the bids solicited by the State of Florida Department of Management Services (432300000-NASPA-16-ACS), a copy of which is attached hereto and incorporated herein, is hereby approved.

Section 3. Payment shall be made in a total amount not to exceed \$300,000.00 from the appropriate Budget Code Numbers on an as needed basis.

Section 4. This Resolution shall take effect immediately upon its passage.
