

**RESOLUTION NO. 25R-09-197**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA, APPROVING THE PROPOSAL FROM PREFERRED GOVERNMENTAL INSURANCE TRUST TO PROVIDE PROTECTED SELF-INSURANCE PRODUCTS THROUGH THE BROKER, PUBLIC RISK INSURANCE AGENCY, FOR THE FISCAL YEAR OCTOBER 1, 2025 THROUGH SEPTEMBER 30, 2026 FOR FIRST AND THIRD-PARTY CLAIMS BASED UPON THE FOLLOWING LOSSES: GENERAL LIABILITY, PROPERTY, AUTO LIABILITY AND PHYSICAL DAMAGE, WORKERS' COMPENSATION, BOILER AND MACHINERY, ERRORS AND OMISSIONS, LAW ENFORCEMENT, INLAND MARINE, CRIME, EMPLOYERS LIABILITY AND SEXUAL MISCONDUCT; PROVIDING FOR A TOTAL PAYMENT \$2,300,410.00 FROM THE APPROPRIATE BUDGET CODE NUMBERS; AND PROVIDING FOR AN EFFECTIVE DATE (REQUESTED BY CITY MANAGER, KENNIE HOBBS, JR.).**

WHEREAS, Preferred Governmental Insurance Trust (PGIT) provides to the City of Lauderhill protected self-insurance products through the Broker, Public Risk Insurance Agency, for the following losses: general liability, property, auto liability and physical damage, worker's compensation, boiler and machinery, errors and omissions, law enforcement, inland marine, crime, employers liability and sexual misconduct; and

WHEREAS, staff has reviewed PGIT's proposal for several lines of coverage and after reviewing the information, staff recommends the renewal of the contract with PGIT, and authorization to bind coverage.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF LAUDERHILL, FLORIDA:

**SECTION 1:** That the City Commission hereby approves the proposal from Preferred Governmental Insurance Trust who provides protected self-insurance products through the Broker, Public Risk Insurance Agency for the following losses: general liability, property, auto liability and physical damage, worker's compensation, boiler and machinery, errors and omissions, law enforcement, inland marine, crime, employers liability and sexual misconduct for the City of Lauderhill for a one (1) year term beginning October 1, 2025 and ending September 30, 2026.

**SECTION 2:** That staff is authorized to bind coverage and make payment in the estimated amount of \$2,300,410.00, on an as needed basis from Budget Code Numbers 001-01-162-50-4521, 001-01-162-50-4522, and 001-01-162-50-4523.

**SECTION 3:** This Resolution shall take effect immediately upon its passage and approval.
